They were examined by us according to the

("Methods for testing papers and boards for food packaging", state of 2008, corresponding to the method no. 80.56 within the Official Collection of Test Methods according to § 64 of the Foodstuffs and Animal Feed Code - LFGB),

as well as to the specific requirements of the

Guidelines of the Council of Europe on test conditions and methods of analysis for paper and board materials and articles intended to come into contact with foodstuffs, Technical Document no. 2, version 3 of 14 November 2007,

and according to the demands of the

Code of Federal Regulations, Food and Drugs (FDA), 21 CFR Ch. I (1 April 2019 edition), § 176.180,

for the used raw materials, fabrication additives and special paper finishing agents as well as for the release of substances which might endanger health.

The paper grades are in compliance with the rules of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, modified by app. no. 5.17 of the regulation (EC) No 596/2009 of 18 June 2009, Official Journal of the European Union L 188 of 18 July 2009, article 3,

as well as of the

The demands of the

Resolution of the Council of Europe AP (2002) 1 on paper and board materials and articles intended to come into contact with foodstuffs of 18 September 2002,

are met by the paper grades. Instead of the not yet evaluated Technical Document 1 on constituents, the list of fabrication additives of the German Recommendation XXXVI was consulted.

Furthermore, the paper grades are in compliance with the demands of the Code of Federal Regulations, Food and Drugs (FDA), 21 CFR Ch. I (1 April 2019 edition), § 176.180.

Thus, the paper grades **Offset Premium – Navigator Paper Figueira, S.A.** and **Offset Premium – Navigator Paper Setubal, S.A.** according to the sample material submitted may be used safely for food packaging. They may stand in direct contact with dry, non-fatty food. According to the German Recommendation XXXVI, the contact with fatty food is also safe.

This certificate of compliance has a validity of 2 years and consists of 4 pages. It was subsequently modified on 4 March 2020.
